- We will always have parties and groups together. In the case of large groups, seating will take place at more than 1 table. We will always try to accommodate special wishes, but we cannot promise beforehand that guests can be seated in a specific area of the restaurant.
- We reserve the right to minor menu changes according to available seasonal ingredients.
- We reserve the right to decline and cancel any reservations and agreements in case the terms and conditions are not followed.
